



## Fully Online Bachelor of Health Services Administration (BHSA)

Effective Fall 2023, applicants to the program will be granted FULL ADMISSION when they satisfy general FIU admissions criteria. Once admitted, students must complete the pre/corequisites listed below prior to enrolling in the Core Course HSA 4170 (Healthcare Financial Management) AND within one (1) year of admission. A minimum grade of “C” or higher is required for all courses. Students must follow regular University admission procedures and upon admission declare their specific major as Health Services Administration. Prior to enrolling in the Core Course HSA 4170 – Healthcare Financial Management, the completion of the Pre-/Co-requisites for HSA 4170, and the State Common Prerequisites with a “C” grade or higher must be met. All students must complete the FIU University Core Curriculum and BHSA program requirements to be eligible for graduation.

**IV. Elective Courses – (15 credits) Students must take electives at the 3000/4000 level and earn a “C” or higher in each course to count towards BHA degree. When choosing electives, students may select:**

- Courses from the list of suggested electives on your Panther Degree Audit. These courses do not require advisor approval; however, they might have prerequisite requirements. Please note that these courses are not scheduled or managed by the Department of Health Services Administration. If you should encounter issues with registration, you must contact the respective department in which the course(s) is/are affiliated.
- Courses to complete a minor. Most minors require 12-18 credits. Therefore, you may need additional courses beyond the 12 credits required for the BHA degree, which may cause you to run into the Excess Credit Surcharge (see your BHA advisor for more information regarding the surcharge). To add a minor, you will need to see an advisor in the respective department to complete the paperwork. - Other 3000 or 4000 level courses not on the approved elective list: for example prerequisites courses required for Occupational Training or Physical Therapy programs may also be taken, provided that a student speaks with a Pre-Professional advisor before registration. - Satisfaction of the foreign language requirement
- Satisfaction of summer requirement
- Cumulative GPA of 2.0 or higher
- Completion of all HSA program requirements with a grade of C or better
- Completion of 120 credits
- No incomplete grades
- Submit graduation application prior to university application deadline
